We have now provided training to a record number of people across all our programs. 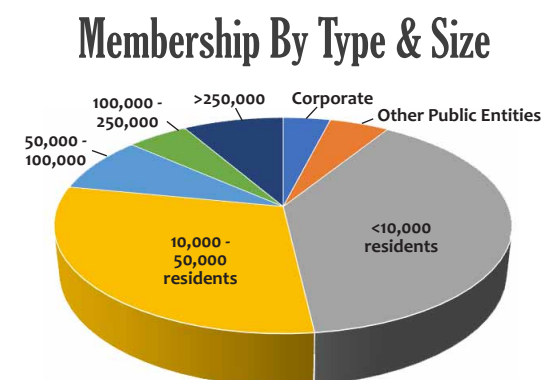


Growth in Membership

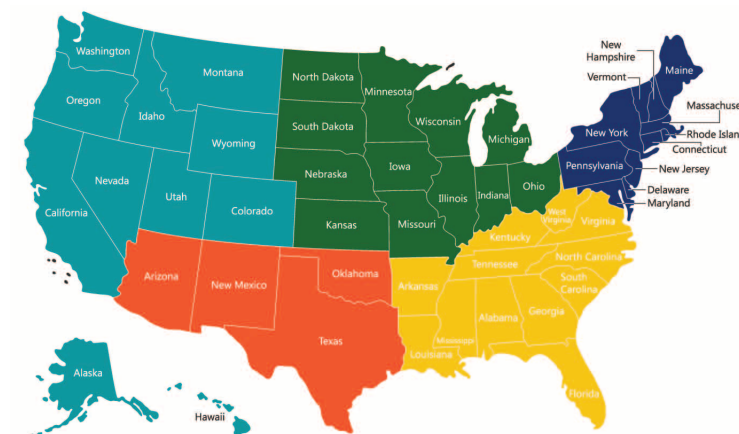

Education Chair Update - Sal Talarico

The Education Committee made great strides this year, building on the base we started in our inaugural year of 2019-20. Following the strategic plan goals, we accomplished and started the following projects:

- Formalized the Committee and started meeting routinely to support strategic objectives.
- Established a virtual training platform to expand continuing education opportunities for treasury professionals across the US and Canada.
- Sponsored 14 virtual trainings, in partnership with ten organizations (associations and communities) and reached 1,814 treasury professionals through 11 Cash Handling trainings and three Internal Controls trainings. *See details on opposite page.*
- Converted the 2021 Annual Conference to a hybrid training event to support both onsite and online attendance.
- Converted the Cash Handling Training Manual to a digital publication.
- Began the project of rewriting the Internal Controls Training Manual to provide up-to-date guidelines for organizations to use to develop internal controls best practices, policies and procedures.
- Introduced and promoted self-guided online education programs through a partnership with MindEdge Learning, Inc.
- Secured hosts/partners through a new Conference Partnership Agreement through 2025.

Education & Training

Cash Handling & Internal Controls Training

With the development of our online education platform, the reach of the Association's training programs have significantly increased. We provided eleven Cash Handling virtual sessions between October 2020 and June 2021 and three Internal Control virtual sessions between November 2020 and April 2021. APT US&C looks forward to continuing to provide these certificate programs both in-person and online to support the training needs for treasury professionals and their personnel.

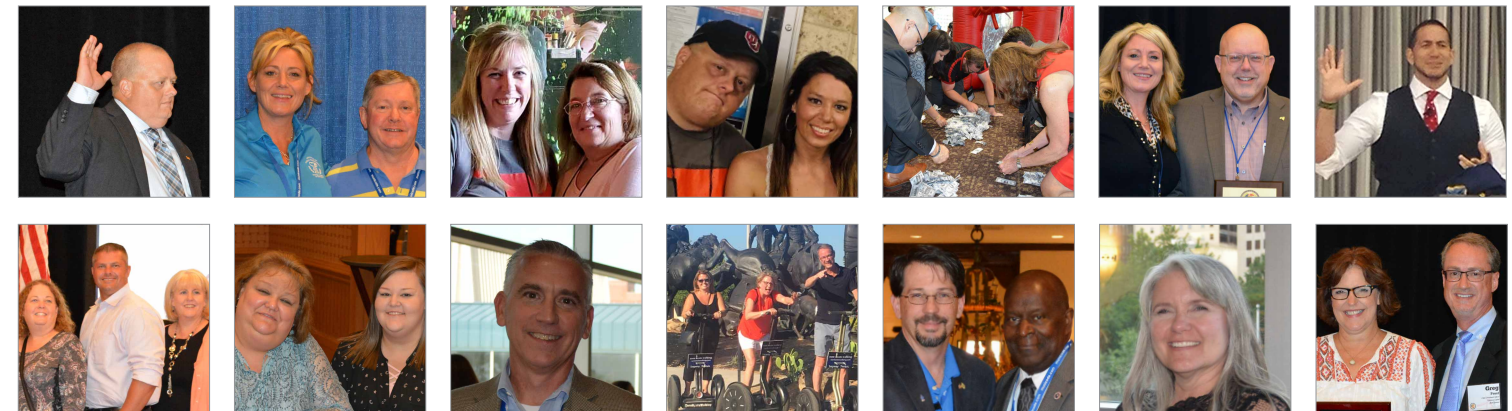

Certification Chair Update - Charri Lara

The Accreditations/Certifications Committee is pleased to share that we continue to focus on adding value to our certifications while focusing on member satisfaction. The following goals have been addressed and achieved by the committee this year in an effort to make working with APT US&C to earn and maintain certifications more streamlined while strengthening the integrity and value of the certifications.

- Formalized a Certifications Committee to support strategic objectives.
- Established re-certification guidelines for the CPFIM (Certified Public Funds Investment Manager) and ACPFIM (Advanced Certified Public Funds Investment Manager) Certification program to add value to these programs by requiring ongoing education to maintain the certifications.
- Revised guidelines for education and experience points and new applications for the CPFA (Certified Public Finance Administrator) program to make the application process clearer for those wanting to earn and maintain the CPFA and ACPFA (Advanced Certified Public Finance Administrator) certifications.
- Hosted two CPFIM and one ACPFIM virtual certification trainings to 97 treasury professionals who earned their certification. We plan to continue providing this training online to reach all treasury professionals interested in investment certification.
- Reviewed 13 Investment Policy applications and awarded 11 Certifications.
- Reviewed 46 CPFA and ACPFA applications and awarded 44 Certifications.

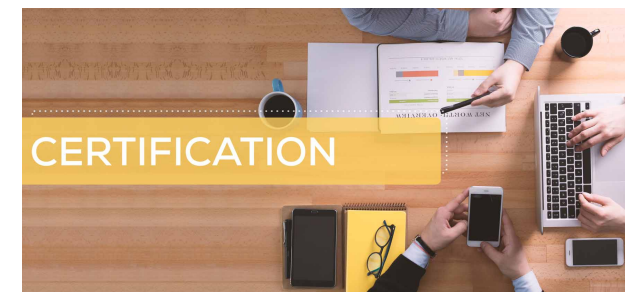

Finance Chair Update - Tricia Wiggle-Bazzy

The Finance Committee met regularly this past year to review the financial reports each quarter as well as to address open issues. I appreciate everyone's attention to detail and fantastic questions on the "hows and whys" of the Association's financial record keeping. The team created a financial policy and the 2021-22 budget and recommended each for approval to the Board, which accepted our recommendations. The committee also started the process of reviewing targeted reports to analyze our investment plan and options moving forwards.

The committee worked closely with the guidelines of the Strategic Plan as we worked on our projects, and are happy to report that this year's financials reflect an incredibly solid position for the Association. Please review the following income and expense comparisons for a quick overview of our financial picture. These numbers are through June 30 for the fiscal year 2020-21, which ends September 30.

- Total YTD Income: \$343,215 (102% of annual budget)
- Membership Income: \$128,012 (101% of annual budget)
- Education Income: \$215,203 (103% of annual budget)
- Total YTD Expenses: \$123,745 (37% of annual budget)
- Total YTD Net Income: \$219,470 (compared to YTD budget of \$94,369 and annual budget of \$4,551)

Also included in this report is a balance sheet comparison on the next page; the financial picture is a great reflection of the teamwork and strategic vision developed by the Board over the last few years.

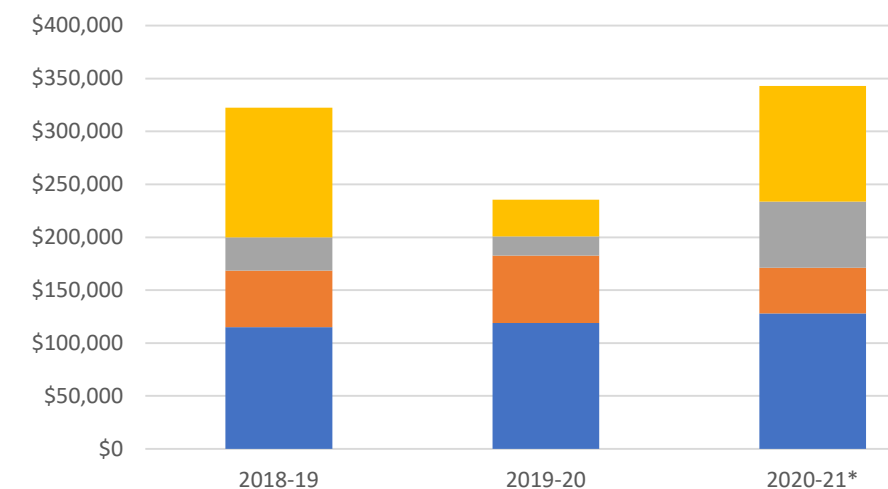

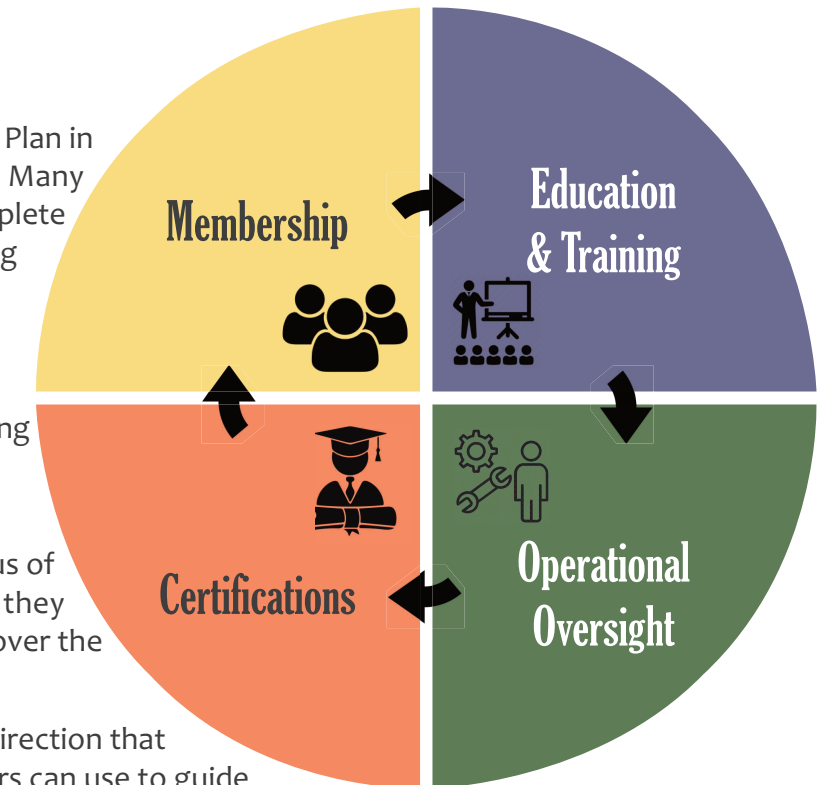
Future Plans
